

# Vice-Chancellor's International Excellence Scholarship for Malaysia - 2024

The Vice-Chancellor's International Excellence Scholarship for Malaysia (prior to 2023 named the University of Waikato International Excellence Scholarship) was established in 2015 to promote educational opportunities, foster internationalisation and support talented international applicants who are enrolling as new students into undergraduate or postgraduate programmes<sup>1</sup> at the University of Waikato. The Scholarships are tuition fees credits in NZD and have a value of up to \$15,000 for undergraduate students and up to \$15,000 for postgraduate students and are awarded to applicants who have demonstrated excellent academic achievement. Successful applicants will be called upon to become global ambassadors for the University of Waikato.

## 1. Eligibility and Selection Criteria

1.1. **To be eligible**, applicants must:

- 1.1.1. be a citizen or permanent resident of Malaysia;
- 1.1.2. be applying to enrol full-time in an undergraduate or postgraduate programme<sup>1</sup>, **as a new international student** to the University of Waikato;
- 1.1.3. have received a conditional or unconditional offer of place from the University of Waikato (including a pathway offer for a degree packaged with the Certificate of Attainment in English Language; the Certificate of Attainment in Foundation Studies; Certificate of University Preparation; International Diploma (Business); International Diploma (Computer Science) or Diploma of Postgraduate Preparation (Pre-Masters)) at the University of Waikato);
- 1.1.4. have a minimum GPA-equivalency of B+ in the qualification used to gain entrance to the University of Waikato;
- 1.1.5. **not currently be enrolled at the University of Waikato in any undergraduate or postgraduate programme and** not have paid fees at the time of application;
- 1.1.6. not be coming to the University of Waikato via a sponsoring body<sup>2</sup>;
- 1.1.7. not be coming to the University of Waikato on a Guaranteed Credit Arrangement<sup>3</sup>, or through a study abroad or student exchange agreement;

<sup>3</sup> Guaranteed credit arrangements are where an institution has a formal agreement with the University of Waikato whereby a student can study part of their degree at the partner institution and credit that study towards 1 – 2 years of study at the University of Waikato.

## **1.2. Selection is based on:**

- 1.2.1. The basis of academic merit;
- 1.2.2. Potential to become global ambassadors for the University of Waikato.

## **1.3. On-going eligibility is conditional on recipients:**

- 1.3.1. Enrolling within 12 months of the dates outlined in the Offer of Place **and** commencing a full-time programme/s of study of at least 120 points at the University of Waikato in the year(s) of tenure.
  - a) The original scholarship offer is valid only within 12 months of the dates outlined in the Offer of Place unless deferral is approved.
  - b) If for any reason a recipient is unable to complete enrolment and begin study at University of Waikato within the same calendar year, they may request a deferral of their scholarship completing the [Scholarships Variation Request Form](#). Approval is at the discretion of the Scholarship Committee and are considered on a case-by-case basis.
- 1.3.2. Residing in New Zealand for the entire tenure of the scholarship and remaining studying full-time on campus.
- 1.3.3. Maintaining an international student status within the University's student system during the entire tenure of the scholarship. Any change in status may result in the scholarship being fully or partly removed from the student's account.
- 1.3.3. Where offers include scholarships with tenure of more than one year, then additional years are conditional on:
  - a) the recipient passing all papers in the first year, and where applicable, in their second year.
  - b) The recipient enrolling full-time in consecutive years (i.e., no suspensions will be permitted between years).

## **2. Awarding, Value and Tenure**

- 2.1 The number of scholarships offered, disbursement of award and value of each scholarship offered is at the discretion of the Scholarships Committee and is based on criteria such as but not limited to: funding available, intended programme of study, duration of intended programme of study, number of credits enrolled and GPA equivalency. The scholarship value will be between \$2,500 and \$15,000, and tenure between 1 and 3 years as follows:

- 2.2 **Undergraduate students** will receive **between \$2,500 and \$15,000** as follows:
- a) **One year tenure:** Between \$2,500 and \$8,000 applied to tuition fees in the first year of full time study (a minimum of 120 points).
  - b) **Two years' tenure:** between \$2,500 and \$12,000, with no more than \$8,000 in the first year of study and no more than \$4,000 in the second year of full-time study.
  - c) **Three years tenure:** between \$2,500 and \$15,000, with no more than \$8,000 in their first year of study, and no more than \$4,000 in year two, and no more than \$3,000 in year three of full-time study.
- 2.3. **Postgraduate students** will receive **between \$2,500 and \$15,000** which will be applied to one year or more of the recipient's postgraduate study.
- 2.4. The scholarship will be applied directly to the recipient's tuition fees for the agreed programme of study either at the time of enrolment or once their enrolment is completed.
- 2.5. Students who are offered a scholarship and have a pathway offer for study at the University of Waikato (see 1.1.2. above) will have their scholarship applied to their degree programme following the successful completion of their pathway programme,
- 2.6. All applicants will be advised of the result of their application through their MyWaikato portal.
- 2.7. **Successful applicants will receive a scholarship offer which is valid for 14 days.** Offers must be accepted by the date indicated or the offer will lapse and no longer be valid.
- 2.7.1. After accepting the Scholarship Offer, recipients will receive an official Scholarship Offer Letter to assist in any student visa application.
  - 2.7.2. Recipients may pay the full tuition fee amount **minus** the value of the scholarship in the offer. They must provide their Scholarship Offer Letter to Immigration New Zealand in order to do so.
- 2.8. In accepting the Scholarship, the recipient will be deemed to have read, understood and accepted the conditions of the Scholarship, and the [Scholarships Policy](#).
- 2.9. The maximum possible tenure is up to three years.

### 3. Application

- 3.1. Applications for the Scholarship can be submitted at any time and decisions will normally be made within 8 to 12 weeks of the time of application. However, applications may not be considered if received within 4 weeks of the start of each of the University's three main trimesters (A, B and C Trimesters).
- 3.2. As part of their online submission, applicants must:
  - 3.2.1. upload their conditional or unconditional offer of place from the University of Waikato.
  - 3.2.2. ensure they provide specific detail when explaining why they want to study at the University of Waikato, and how they will be a global ambassador for the University of Waikato.

### 4. Selection Panel

- 4.1. Applications will be ranked and recommended according to the Selection Criteria by the International Office and forwarded to the Selection Panel for consideration.
- 4.2. The Selection Panel will comprise the Chair of the Scholarships Committee and the Director – International (or their nominees).
- 4.3. The Selection Panel's decisions are final and no correspondence will be entered into following each selection meeting.

### 5. Other Conditions

- 5.1. The Scholarship may **not** be held in conjunction with:
  - 5.1.1. any other University of Waikato funded tuition fees scholarship, award, bursary or other such funding, **or**
  - 5.1.2. any Education New Zealand scholarships or Manaaki Scholarship.
- 5.2. If, during the tenure of the Scholarship, a recipient's circumstances change in such a manner that their continued eligibility for the Scholarship may be affected, they must inform [scholarships@waikato.ac.nz](mailto:scholarships@waikato.ac.nz) immediately.
- 5.3. The Scholarships Committee may terminate a Scholarship at any time, and recoup any funds disbursed, if the holder is not following the approved programme of study, withdraws from the University during the tenure of the Scholarship, brings the Scholarship or University into disrepute<sup>4</sup>, or is not otherwise complying with the regulations governing the Scholarship and/or the University of Waikato. The recipient will have the right to appeal against any

decision to terminate the Scholarship.

- 5.4. By accepting a Scholarship, the recipient agrees to participate in any reasonable publicity concerning the Scholarship arranged by the University of Waikato.
- 5.5. Any ambassadorial duties will be at the discretion of the International Office. Any queries in regards to these duties can be made to [gowaikato@waikato.ac.nz](mailto:gowaikato@waikato.ac.nz).
- 5.6. The Scholarships Committee has the power to amend or vary these regulations provided that there is no departure from the main purpose of the Scholarship.
